Minutes of the Halton & District Special General Meeting meeting held at Pavilions 7th August 7.15pm all clubs were in attendance except:Cromwell,Fc Parklands,Runcom Panthers,Upton and Wolves.

The meeting was opened by the Chairman thanking all for attending the meeting and asked had you signed in.

The special general meeting was called to discuss and vote on the merger of the u16's and u17's to merge together, after the AGM were it was voted to remain separate, since then some u16's have pulled out and it will be down to 4 teams in the u16's so it is advised to merge the two age groups. After a short discussion the floor voted for the merger and it was 30 for the two age groups to merge, 3 against and 5 abstentions.

The vote was carried and the two will merger go ahead and it will be called an u17's League.

2. Halton Villa asked that could for this year only if the merger went ahead that the u17's have 18 players in a squad due to it being late notice, as they have already picked a squad of 16 u16's and would like to invite the older players back.

The League explain about there would be no roll on roll off and it would be 3 from 5 subs allowed so it would mean you have lads on the side line who are not even going to get on.

the vote was 26 for , 3 against, 12 abstentions.

The vote was carried and the squad size for the u17's for this year only will be 18 players.

The Meeting was closed and the floor was thanked for attending.
