The minutes of the Halton & District Junior League meeting held Thursday 12th August 2010 8.00pm at Pavilions all clubs in attendance except:,Beechwood,Wolves,Sutton Rangers,

The Chairman welcomed all to the meeting and asked had you all signed in and was there only 2 delegates per club.

1.Minutes of the last meeting:The minutes were passed.

1.1 Matters Arising:The date on the agenda for tonight should say 2010 not 2011.

2.Finances:Jane White told the floor the balance was £8,611.12p which included club deposits .Jane told the floor that hopefully the respect barrier kits were going to be ok for us to us and if they are they will be available from Best Sports at a cost of approx £45 we will let you know soon if they are long enough.League fees need to be paid by 24th August.

3.Registration Secretary:Mrs M.Mainwaring said as of next year any passport ID for proof of birth will need to be a valid one and also Managers will be asked to provide ID for their forms.Not alot of teams have Managers/coaches registered please note only coaches wearing valid laminate will be allowed to stand at pitchside,and anyone found to be doing so without badge will be liable to bye law S.

4.Teamsheet Co-Ordinators:Mike Galbraith Mini Soccer & Jason Bate 11-aside:Both were unable to attend again and the Committee has discussed this and have decided to ask them both to step down from these posts,David Seddon and Jane White would like to do this Jane said it would be easier for her to do them and issue any fines also as she is doing the fines anyway so the Committee left it up to them to decide,it was given out that Jane will receive the teamsheets via royal mail only for both Mini and 11 aside you must not post them through her door anyone doing so will incur a fine and the club will be contacted.The address will be on the teamsheet 25 Barncroft ,Norton,Runcorn.

For Sat/Sun games they need to be recieved via the post on the following Thursday for Tues games received on the Saturday post for wed games received by the Monday post and for Thur games received by post on the Tuesday.

4.1 Welfare Officers Jackie Feeley & Julie Cole: New CRB forms out from 1st July all CWO 's need to know how to do these so contact us or County.The price is now £15.

4.2 Charter Standard League:Dave Wilson had nothing to report.

5.Mini Soccer Fixture Secretary:Mr M Mainwaring said to check if your club details are correct on the web and to verify age groups.

6. 11-aside & Web site Dave Wilson: Dave cant do fixtures until pitches have been allocated so let him know as soon as possible.

7.Referee's Secretary:Mr D.Seddon said Referee's list will go out soon and don't forget to confirm them by the stated times in handbooks.If Referees do not show up for games without reason let us know so we can look into it.Please don't all keep ringing David after 8pm if a Referee cannot keep his appointment on a Friday night there is not alot we can do for the very next morning.

8.Runcorn & District FA Julie Cole: Cup forms are available of f Mike and most have been sent and deadline is very soon.Played on a Sunday and it is u12's , u14's and u16's so if you are u13's and enter the u14's cup you could have to play an u14's opposition.

9.Correspondence:New address for League Secretary is 9 Whatcroft Close Halton Lodge,Runcorn WA7 5YY, the following was given out at last meeting and was spoke about again tonight:

Under rule 10 B this league and the FA do not allow any child under 17 years old to play in 2 matches in one day this means if a child plays for even 5 minutes in a game somewhere then he/she must not go and play again somewhere else for another team that day, the 100 mins rule does not apply as people seem to think this is a totally different rule that applies to double header games between the same 2 teams if the league have got games back logged due to weather etc, and the 100 mins is the maximum for the older ages anyway, also if a child does not play the teamsheet must show DNP for that player if they have signed they will be deemed to have played and they will be an ineligible player no matter what the reason is under rule 11A,B & C, these rules also requires a letter to come in if you mark the Referee 50 or below.The Mini soccer festival is mandatory for all u7's and u8's in this League.Some clubs still need to show copies of affiliation and personal accident if this is not done next week you may not be allowed to play.

10 A.O.B (Notification of which was made in writing at least 7 days prior to the meeting)At the last meeting Ian Perry weston Point asked why we was not given the League medals a discussion was held which the floor was told 600 medals were not even picked up from Best Sports and the money that wastes is alot ,the floor was told to get some feedback and discuss at the next meeting unfortunately only 4 clubs bothered to contact us to say they wanted them so we wont be changing our decision on this.

Heath Athletic sent a letter in regarding the merge of the u16's and u17's after a short discussion about wether it was beneficial or not majority agreed it was only right to merge rather than have 3 u17's not playing at all,Joanne asked could we only ask the u17's to sign for u17's clubs and not join the original u16's but we told the floor this was not possible as they could sign for either as the merge allows.
